- Suggestion to meet with presenters and find out more about the speakers and share information about OPHA
- Suggestion to create communication and values statements to share with speakers
- The executive committee will create some broad guidelines/prompts and share it out with the board at the next board meeting
- Addressing an extended board absence
 - o Three unexcused absences is cause for removing a board member from the board
 - Currently there is a board member who has missed over three board meetings. Several attempts have been made to contact the board member and this board member has now moved out of the area.
- Motion to vote to remove board member board member from the board per the OPHA bylaws from Julie, from the board. Motion passed unanimously Cristian votes to remove Juan Franco, Julie second, unanimously passed.
 - This board member will be removed and the vacancy will be filled sometime after October
- Chairperson for the Elections Committee is needed
 - Voting is done electronically
 - Present election results at annual meeting
 - o Chairperson must identify two non-board members to also serve on the committee
 - Christian volunteered to serve as the chairperson
