1:00 Call to Order - Craig Mosbaek

Introductions/Roll call

1:05 August Meeting Minutes – April Lawless – Information and Adoption (vote)

Motion to accept August meeting minutes passes unanimously

1:10 Treasurer's Report – David Huntley – Information and Adoption (vote)

- August financials
 - o Travel for speakers may be slightly higher than usual
 - Net income is on track
 - Profit and Loss overall is slightly high because of revenue from training
 - Treasurers Report
 - Craig moves we accept the Treasurers Report as reported and the change in the Disability Section budget
 - Marti offers the 2nd
 - The motion passes unanimously
- Revised Disability Section budget
 - The request is to approve the travel expenses associated with the conference scholarship requests. They have a surplus from last year.

1:20 President's Report – Craig Mosbaek – Information and Discussion

- Looking for someone who is interested in facilitating the PH organization policy meetings
 - o Could be someone internal to the group or outside the group
 - Let Craig know if you have someone in mind
- Retreat planning committee
 - Looking for people to assist with planning the retreat
 - Tom and Robb expressed interest
- Process for new revenue generating programs
 - EC discussed and decided that this should not be the current Program Committee's responsibility and that the focus should remain on the annual conference planning
 - The idea of creating another sub-committee within the Program Committee called "Events" would work on revenue generating events. We are looking for someone to chair the "Events" sub-committee.
 - The current conference fundraising work will continue to be done under the Development Committee
 - Marie Harvey will continue to chair the Program Committee and the Annual Conference Planning subcommittee
- Board member resignations Tony Lapiz (director-at-large) and Elizabeth Sampedro (Region 3 Representative). Region 3: Northwestern Oregon – Clatsop, Columbia, Lincoln, Tillamook, Washington, and Yamhill Counties).
 - Brainstorm list of names for open board positions:
 - Consider focusing on recruiting Native American or African American candidates for board positions
 - Because these are board vacancies in the middle of the term, we cannot use the general membership ballots. The board elects replacements when there is a vacancy

- A policy was developed to assist the board in their recruitment. Part of that policy is to first generate a list of names during the board meeting.
- Jessica would like to see the board vote on the candidates in October so that they can be involved in the November board member orientation
- We asked that the candidates provide a brief bio and statement of why they would like to join the board
- Send Craig names if you have people in mind. We want to be careful to reach out to
 1-2 people at a time to confirm their interest.

1:40 Executive Director's Report – Jessica Nischik-Long – Information and Discussion

- Nominations update
 - We have a person running for every open position
 - The ballot was sent out
 - o The board has appointed people to the Elections Committee to count the ballots
- APHA Climate and Health Equity grant update
 - APHA has a new center for climate change and equity issues. They are offering a small amount of money to member groups to further the affiliates climate change work. - o 2019 Legislative debrief
 - o Legislative Session Scorecard
 - o Closing weeks of the session were very confusing and chaotic
 - Bill that would remove the medical exemption for immunizations will likely be back in the short session
- Member engagement survey results
- Board guidance for 2020 legislative session
 - o Recommendation is to have fewer policy issues on the list that OPHA focuses on
 - Survey results show strong interest in climate change and immunization issues.
 Possible other areas may be marijuana use/vaping education and prevention and gun safety.
 - A reminder was offered that we may want to make OPHA's focus on health equity more transparent and that we flag bills that specifically focus on health equityrelated issues.
 - o Each legislator can introduce two bills
 - Marti moves that OPHA prioritize climate change/clean energy jobs bill and vaccine non-medical exemption issue
 - Tom Engle provided the 2nd
 - The motion passes unanimously
- Public Health Advocacy Day planned for Feb 6, 2020
- o Climate, Health, and Equity Call to Action
 - Emily York, Chair of Healthy Environments Section Chair, presented the Call to Action
 - Board supports this work and moving it forward
 - The Healthy Environments Section will host a table at the 75th Celebration as another place to promote this call to action.
